

# Requirements for Minors Taking the CFSC & CRFSC



## Minor Consent Form

**Minors taking the CFSC or CRFSC must provide written consent from their parent or legal guardian by submitting a signed and dated Minor Consent Form.**

Submit the completed Minor Consent Form with the course paperwork and check the Minor box on the Mandatory Course Report

### Acceptable Identification

The following is a list of acceptable photo ID for the CFSC/CRFSC course and examination:

- Any recognized government identification (Military, Ministry, etc.)
- Passport (any country)
- Driver's Licence (any province)
- Ontario Photo Card (or other government-issued provincial photo identification)
- A letter from the bishop of the Mennonite community

For students under the age of 18 (Minors) without any of the identification listed above, acceptable identification options are:

- Birth Certificate **and** a valid School Photo ID
- Birth Certificate **and** the Parent or Guardian's identification from the list of acceptable identification above

Record both sets of ID (the minor's and the parent/guardian's on the course report form.

### Minors Attending the CRFSC

Minors are permitted to take the CRFSC; however, they cannot complete the written or practical examination. Minors who wish to obtain a PAL with restricted privileges must retake the CRFSC and pass the written and practical exams once they turn 18. Please ensure you advise all minors and their parents/guardians of this requirement.

When completing the paperwork, write "For Educational Purposes" on the MCR section for the student's exam marks. You do not need to complete an RCMP Student Course report for a minor taking the CRFSC.

# Requirements for Minors Taking the CFSC & CRFSC

## **Parents Attending the Course**

Parents are permitted to attend a course with a minor, but they cannot be present during the written or practical exam unless required for accommodation purposes. This accommodation must be identified and approved in advance of the course. Parents accompanying a minor do not count in the instructor-to-student ratio, and they cannot participate or handle firearms at any time during the course or examination.
