GRAND MASTER'S EDICT NO. 27-001

**TO ALL MASTER MASONS OWING ALLEGIANCE TO THE MOST WORSHIPFUL PRINCE HALL GRAND LODGE,
STATE OF WASHINGTON AND JURISDICTION:**

AUTHORITY

Know ye by these presents that this Edict is issued under the authority of **PART I, ARTICLE 12, POWERS OF THE GRAND LODGE**, and **PART I, ARTICLE 13, POWERS OF THE GRAND MASTER**, of the Masonic Code of the **MOST WORSHIPFUL PRINCE HALL GRAND LODGE, WASHINGTON AND JURISDICTION, REVISION: 2024, UPDATED: 2025**.

This authority includes the provision of **Article 13, Section 13.01.03**, which states that when the Grand Lodge is not in session, the Grand Master shall possess and exercise the powers and functions of the Grand Lodge.

DIRECTIVE

I, **ANTONIO D. GRAHAM**, 51ST GRAND MASTER OF MASONS, hereby **DIRECT** that **ANY** and **ALL Masons** under **SUSPENSION**, or otherwise **SUSPENDED** by this **MOST WORSHIPFUL PRINCE HALL GRAND LODGE** or by the **GRAND MASTER**, including suspended Master Masons sojourning within this Jurisdiction, are subject to the restriction set forth below.

RESTRICTION

No such Mason shall **ENTER** or **TRESPASS** upon **ANY PROPERTY BELONGING** to this **MOST WORSHIPFUL PRINCE HALL GRAND LODGE**, under any circumstance and without exception.

This **OFFICIAL EDICT NO. 27-001** shall remain in effect until such time as it has been rescinded by this office and **ALL Master Masons are to take due notice and be governed accordingly**.
