On Saturday, September 12, 2026, Everett Consistory #118, Our host Consistory will open the Council of Deliberation on Friday night in ritualistic form and resume labor at 8:00 am.

All present will be properly attired; dark suit, black tie, white shirt, black shoes, black socks, white gloves, crown and Scottish Rite jewel of your attained grade, robes can be worn. The annual banquet will be held at 6:30pm until 10:00pm.

All Grand Inspectors General, the three principal officers of the Consistory, the three principal officers of the Rose Croix, and the four principal officers of the Lodge of Perfection are to be registered and in attendance unless excused by the Deputy. All principal officers of the three bodies will render their annual report. An advanced copy of each report will be forwarded to the Deputy (NLT) August 20, 2026, not later than three weeks prior to the convening of the Council of Deliberation. All Committee Chairs will prepare a written report and have sufficient copies for all participants, even if a negative
