SUBJECT: LETTER OF INSTRUCTION (LOI) FOR THE COASTAL GEORGIA RAIDER INVITATIONAL 26 SEPTEMBER 2025

1. Purpose: This LOI announces the 2025 Coastal Georgia Raider Invitational to be held at Jekyll Island, Georgia, on 26 September 2025. This competition is meant to give teams a new, challenging meet at one of the most premier locations the state has to offer in order to further expand Raider in the southern/coastal region of Georgia.

2. Scope: The Coastal Georgia Raider Invitational is designed to:

- a. Offer cadets a physically demanding competition
- b. Promote a competitive spirit among the participants
- c. Provide a physical fitness challenge
- d. Develop respect and self-esteem among cadets
- e. Provide a challenging coastal terrain not found in any other Georgia competition

3. Specifics: The meet will start with a coaches brief at 0800 on 26 SEPT 2025. There will be a total of five events with a ten-person team competing and a two-person Ultimate Raider event.

a. TEAM RUN: 4-Kilometer team run. **This will be the first event for all teams.** Conducted on the southeastern beach of the island, known as Glory Beach, it will be conducted over a mix of soft and compact sand. Teams will run in PT gear and running shoes.

b. ONE ROPE BRIDGE: Ten Member Team must construct a one-rope bridge across a span of approx. fifty feet. Teams will provide and transport their own swiss seats, rope and snap links. A kern mantle or standard nylon laid (minimum 120ft) rope may be used. While timed separately, this event is conducted at the halfway point of the team 6K ruck.

c. TEAM 6K RUCK: Ten Member Team will negotiate approximately 6-kilometer out and back course carrying (4) rucksacks and all necessary equipment to conduct the one-rope bridge at the half-way point.

d. SANDBAG RELAY: Ten Member Teams will conduct a relay of 10 sandbags.

e. RAIDER FITNESS CHALLENGE (RFC). Ten Member Teams will navigate a series of obstacles on the practice field to include Serpentine, Tire Dance, Low crawl, and Equipment Carry. The entire team will start and finish together.

GENERAL INFORMATION

1. The competition will be held on and around the Jekyll Island 4-H Center, including the beach to the east and trails/roads on the west side up to Summer Waves water park.
2. The event headquarters, awards ceremony, medical, billeting, and concessions will be located at the Jekyll 4-H Center.
3. Public School Buses (w/govt license plate) are allowed free entry onto Jekyll Island. General entry is \$10 and discounts are available for veterans with service-connected disabilities. More information can be found at <https://www.jekyllisland.com/visiting/parking/>
4. Trophies will be awarded for First, Second, and Third Place in each event for Male, Mixed, and Female categories. Trophies will be awarded for First, Second, and Third Place overall in each team category.
5. **If a team DQs on any event, their final placement will be below teams that completed all events, regardless of score.**
6. Graders will be provided by recruiters from the Brunswick area. Team coaches may be asked to be graders if a need arises.
7. Team Composition.
 - a. Male, Mixed, and Female teams will consist of up to 14 members, but only 10 will be allowed to compete in any one event. Mix Teams must have a minimum of (4) four females. Schools may enter "A" and "B" teams if they choose.
 - b. Competing cadets will only be allowed to compete on one team only; meaning a cadet on the male team cannot be a substitute for a cadet on the mixed team.
8. ACU/OCP/MARPAT trousers, boots and tan or team T-shirt will be worn for all events except the team run. **Team run will be conducted PT Gear and either boots or running shoes.**
9. Upon completion of the beach run, teams will be assigned to one of three groups to negotiate the 6K Ruck / Rope Bridge, Sandbag Relay, and RFC.
10. The entrance fee for the first team will be \$150.00. Each additional team will be \$100.00
11. Each team should have a release from liability forms included in this LOI for each cadet participating in the competition. **These forms will be collected upon check-in by event staff.**
12. Team tent area will be in the grass area surrounding the soccer field on the north side of the 4-H center.
13. Score sheets for the events will be provided in the school packets upon check-in.
14. **Coaches Meeting will begin at 0800 with the Competition starting at or near 0830 hours.**
15. A nurse will be on-site throughout the competition. Teams will treat minor injuries internally and, in the event, a higher level of care is needed, EMT will be contacted by event HQ.

Parking. Buses will unload personnel and equipment at the main bus ramp for the 4-H center. Once unloaded, buses will park in the lot adjacent; no cars are authorized in the bus lot. Team trailers will enter at the soccer complex and park in the bus lot once off-loaded. All other vehicles will park in the soccer complex or where is allowed along the road.

Concessions. The concession stand is centrally adjacent to the awards field and will offer a variety of drinks, snacks, and candy.

Restrooms. Restrooms are located in the concession stand area and on the north side of the soccer field.

ANNEX A
TEAM RUN:

- a. The Team Run will be conducted on the beach to the east of the 4-H center. The route distance is approximately 2.5 miles (4 Kilometers).
- b. Uniform for this event will be unit PT gear and running shoes or boots (coaches' choice).
- c. THIS WILL BE THE FIRST EVENT FOR ALL TEAMS.
- d. One member of the team will wear a numbered penny jersey to identify the school to the time keepers.
- e. Teams will line up at the start point accessible via the walkway from the 4H center. The order will be published with the final rotation schedule.
- f. Teams will be released on 1-minute intervals.
- g. All team members will start and end together. All members must be in the 10-meter box prior to crossing the finish line.
- h. A member dropping out of the run will result in a five-minute penalty assessed to the team. If more than one member drops out of the run the team will be disqualified.
- i. Medals are awarded to the top three teams in each category.

ANNEX C
TEAM RUCK

- a. Each team will run a predetermined course. The course will be an out and back from the 4H center to the Summer Waves water park.
- b. This event is combined with the one-rope bridge. While the team will have a separate one-rope bridge time, the team ruck is the total time to complete the movement and crossing.
- b. Each team will carry 4 rucks (male/mixed) / 2 rucks (female) weighing 35-40lbs and all equipment necessary to construct/cross a one-rope-bridge.
- d. All equipment must be carried throughout the event and cannot be dropped or thrown.
- e. Once the team reaches the rope bridge site at the half-way point, the team will stage the rucks and conduct a crossing. **The rucks will not go across.**
- f. Upon completion of the rope bridge, the team will retrieve all rucks and equipment and return to the start point.
- g. The timer will stop when the last team member crosses the finish line.
- h. Uniform will be ACU/MARPAT trousers and boots.
- i. The team is not required to stay together, however, once a cadet crosses the finish line they are not allowed to assist. If teams place gear short of the finish line, a gear guard must be posted.
- j. Medals will be awarded to the top three teams in each category.

ANNEX B
ONE ROPE BRIDGE

1. One Rope Bridge
 - a. Each ten-member team must construct a one-rope bridge spanning a fifty-foot distance.
 - b. Teams may use either a Nylon laid 120-foot rope or Kern mantle rope to construct the bridge.
 - c. Teams will tie Swiss seats and set up the rope site upon arrival. While a part of the overall Team Ruck time, this is not part of the one-rope bridge time.
 - d. The first and last man may wear sling ropes properly tied around the waist, Minimum two wraps around the waist secured with square knot and tied off with an overhand knot or half hitches on each side of the square knot.
 - e. The judge will inspect each seat as they are tied. Failure to tie a correct seat will result in a penalty and a delayed start until fixed.
2. The rope bridge will be graded in the following manner:
 - a. Each team will start at a designated rope bridge point and build the rope bridge, cross the dead zone and disassemble the bridge.
 - b. Time starts when the rope is touched to initiate the crossing. Time will stop when the team has crossed the bridge, the near side has crossed the dead zone, all knots are out of the rope, and the team captain states "Time."
 - c. The rope does not have to be coiled in any special manner after being torn down but will be free of any knots at the finish line.
 - d. The judge will give the team the "all clear" command to retrieve the rope bridge equipment for the return to the team ruck portion.
3. Penalties will be assessed according to the rope bridge score sheet. (Annex).
4. Uniform will be ACUs/MARPAT with boots and T-shirts. Any equipment left will result in a 10-second penalty.
5. A rope that fails or falls will result in that team being disqualified.
6. Medals will be awarded to the top three teams in each category.

ANNEX D

SANDBAG RELAY

1. The Sandbag relay will be conducted on the soccer field
2. Equipment Relay. This 10-Raider activity has the Raider team breaking up into two groups of five. Raiders 1 through 5 will move ten, 30-pound sandbags (six for female division) from Circles A through F. Raiders 6 through 10 reset the course. Time stops when all sandbags are returned to Circle A.
 - a. To start, Raider 1 will grab up to two sandbags from Circle A, carry them around a cone 25-yards away, and then run the bags to Circle B where they will be set (not dropped or thrown!) down.
 - b. Raider 1 will then return to Circle A in the most direct manner possible to repeat this process until all ten sandbags have been moved to Circle B. Raider 2 will carry any available bags from Circle B to Circle C by carrying them around a cone 25-yards away.
 - c. As soon as Raider 3 has any bags to carry in Circle C, Raider 3 will carry those bags around a cone 25-yards away and place them in Circle D.
 - d. This process will continue until all ten sandbags have been moved by Raider 5 from Circle E to Circle F.
 - e. At this point, Raiders 6 through 10 repeat the process in reverse Circle order until all sandbags have been returned to Circle A.
 - f. For mixed teams, females will be Raiders 4 through 7. Raider 4 will only take six of the ten sandbags brought to Circle D, leaving the other four, and move them to Circle E where female Raider 5 will take the bags around the cone to Circle F. Female Raider 6 will take the six sandbags from Circle F around the cone to Circle E where female Raider 7 will take the six sandbags from Circle E around the cone to Circle D. At that point, Raider 8 needs to move all ten sandbags around the cone to Circle C and so on.
 - g. No Raider can do the course twice so a weaker Raider does not get a turn.
 - h. If a mixed team uses more than four females for this event, only female Raiders 4 through 7 carry six bags. In other words, any addition female will be required to carry all ten. Last, also for mixed teams, because female Raiders 4 through 7 are carrying six bags, this means that there are four bags waiting in Circle D as mentioned above.
 - i. Raider 8 cannot begin moving those bags early in an effort to get a head start on getting those bags moved from Circle D to Circle C. Raider 8 can only begin carrying bags when female Raider 7 starts bringing the bags from Circle E to Circle D. With regard to female division teams choosing to use less than 10 females on this event, please know that all six bags must be transported through the entire course. If a female division team decides to use less than 10 females, they are committing at least one (in the case of a nine girl team) or two (in the case of an eight girl team) to have to run the sandbags multiple times.

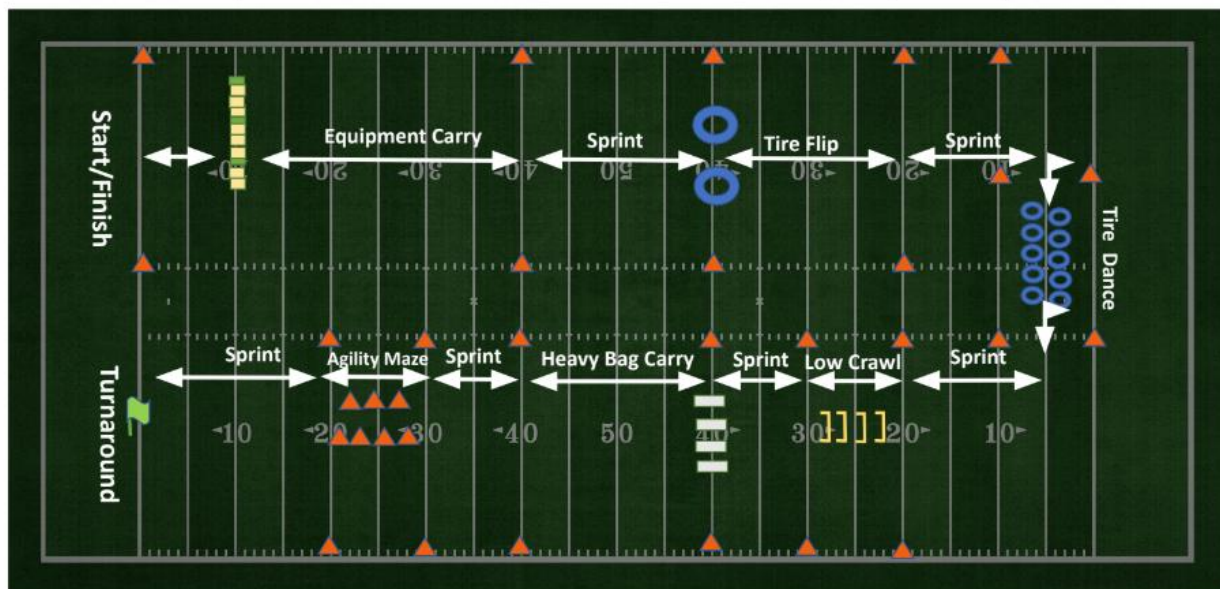


ANNEX F

RAIDER FITNESS CHALLENGE (RFC)

1. The RFC will be conducted on the Soccer field.
2. Uniform for the event will be ACU/MARPAT, team T-shirt, and boots.
3. General Scenario: The RFC is the team event designed to test the strength, strategy and endurance of a team of cadets over 400 yards through a variety of physical obstacles.
4. The team score is the time it takes to complete the tasks, put all items used back in their approximate starting positions, and finishes the course with all team members.
5. Time to complete the course will be kept and recorded for each team.
6. Judges and/or monitors will be stationed along the route to ensure compliance with all rules. A team may be removed from the course at the 8-minute mark for failure to progress. c. The team will be assembled behind a starting line. The grader will command, “Get Set, GO!” or similar. The GO command will start the clock. At that point, the team begins the course.
7. The course will consist of the following items in order
 - a. A 30- yard Water Can carry (6 cans) & 60lb. Ammo Can carry (14 cans).
 - b. Tire flip (2 for male/mixed, 1 for female)
 - c. Low Crawl
 - d. Tire Dance
 - e. Agility maze
 - f. Heavy bag carry (4 total)
 - g. Turn Around Flag/Pole
