Report of the November Guest Speakers – Steve Oakey and Jamie Beal


Although our scheduled Guest Speaker, Harry Lennard, was unable to join us we were fortunate to have a distinguished visitor who agreed to speak on the evening and our Training Officer who provided decision making challenges to the audience.

Firstly, we were welcoming Steve Oakey, Chair of the Referees' Association and Board Member for QUEST.

Steve began by providing an overview of his own career which began in 2001/2 and whilst he progressed to be a L3 Referee he had to step back to L5 due to asthma brought on by Covid in 2022. He now referees in the Gloucestershire and Wiltshire County leagues so has a good understanding of the challenges faced by the grassroots Referee.

He is a member of Cheltenham RA having previously served as the Chair of Cheltenham RA and Training Officer. He joined the RA Board in 2022 and was elected Vice Chair in 2023 and then Chair.

He demonstrated his desire to see the Referees' Association provide a voice for Referees and provided an insight into the work that the RA is doing to Support, Inspire and Develop members.



The RA has an Internal team of legal professionals and an agreement with the barristers group, Advocate, that is able to provide support to Referees that may be involved in legal cases (e.g. following an assault) or subject to disciplinary action (e.g. use of inappropriate language or social media posts).

Steve emphasised, like we have previously stressed to members, the need to contact the RA at the earliest opportunity so they can help to support, not after the event when it is often too late to do anything meaningful.

Other benefits and support have been arranged in part, because of the reach of the RA including discounts on equipment (Boot Buddy, Ref Six etc.) and access to more specialist services (such as Mind).

Other benefits in recent seasons have been free tickets to FA Trophy and FA Vase finals and some England Games.

The RA has been able to utilise members operating at the highest levels to help inspire and develop Referees with Zoom calls with FA Cup Final officials (both male and female), Premier League officials (such as recent "Evening with Peter Bankes") and specialist groups such as football officials from Futsal and the RA Women's Group (of which 2 audience members were part of).

Steve spent a little time talking about the recruitment and retention of referees and informed the audience that in 2023/2024 nearly 10,000 referees were trained yet the overall number of referees, season on season, is not improving because so many are not re-registering.

Based upon the limited analysis that he has been able to do (surprisingly there is no historical data) Steve was able to advise that there was an inverse relationship between dropout rates and RA membership (i.e. fewer RA members fail to renew).

However (which certainly surprised many) for the first time ever, all 50 County FA's have the same strategic framework to follow so there is some hope that the registration and retention of new referees will be improved going forward.

Steve was keen to advise that whilst the RA can do some things centrally it is the Local RAs that can steer members at an early stage through the use of WhatsApp and virtual meetings. This is something that we have been looking to develop further.

A vote of thanks was given Alan Donovan.



The second part of the evening saw Jamie Beal ask the audience to watch a selection of match incidents and make decisions in respect of challenges as to whether they were:

- Careless just a foul (and blue card)
- Reckless warranting a yellow card
- Serious Foul Play / Violent contact warranting a red card

Jamie emphasised the need for officials to have a strong process so they are able to make consistent judgements, often at times of heightened pressure. This came through as:

- See analyse what has happened
- Recognise the nature of the challenge
- Think take your time and decide what action is required
- Act Apply Law correctly and with confidence

This part of the evening clearly demonstrated the benefits of talking through match incidents with colleagues and seeing how different opinions shape the decisions made that can help referees develop further



December meeting – Phil Crossley

We are delighted to have Phil Crossley as our forthcoming speaker

Phil first got into Refereeing in 1990 after seeing an advert in a match day programme after watching Crystal Palace v Liverpool. He had just finished playing local parks football after an achilles injury and wanted to stay active, so he thought I'd give it a go. He took some night school classes to pass the test and then embarked upon his career by joining both the Metropolitan and Sportsman Sunday Leagues. He admits he had no idea what so ever about the Refereeing and pyramid systems. He went from Level 3 to Level 1 in consecutive seasons.



He then joined the Suburban League and after a short period of time got promoted to the Isthmian League where he stayed until the age of 40. That season he achieved the double jump i.e. being promoted to Referee on the Conference and be an Assistant Referee on the Football League. He then achieved promotion to the Football League in two seasons at the age of 42. Within 3 Years he had refereed on the Premier League. He continued combining both his Refereeing career with his personal career in the City, as at that stage they didn't have professional full time contracts. Throughout his career he endured several bad injuries i.e. Knee surgery, shin splits and a very serious collison on the FOP whereby he ended in intensive care having broken 9 ribs in a game between Derby County and Leeds United. He is very proud to say that he never failed a fitness test in the various guises they took place.

In 2011 he decided it was time to retire from the game, finishing on his own terms at the top level. His last game was Leeds United v Burnley. He still felt that he had something to offer therefore trained to become an Observer, something he continues to do. In recent years he has also taken onboard coaching roles, he currently coaches one Level 4, one Level 3 and 5 Level 2 Referees. He has been to both India and South Africa several times working for the FA delivering coaching courses. His major achievements read as follows :


Safeguarding

At grassroots football alone, the promotion criteria as it stands requires referees to attend theory and fitness development sessions throughout the season. On top of this, many dedicate themselves to further development, such as joining a local Referees' Association.

When I accessed the Whole Game System last month, it was brought to my attention that the system we be closing for the 2025-26 season.



From my experience, WGS has been very poor, I can say that with 44 years experience in software development within IT. The layout is mediocre, the performance poor which has deteriorated in recent years. Saving is hit and miss, and unreliable. Some players are listed under clubs more than once, one in mixed case and one in capitals. That should not be possible.

The text box for dismissals and general misconduct will not save the text properly. I've tried to add small bits of text and repeated it but it still doesn't seem to save everything.

Last season when I only managed to save part of the text for a violent conduct report, I was contacted by County and then I emailed the whole report. I was notified some weeks later to say the red card had been quashed by London FA with no explanation. I asked on what basis the decision had been reversed but they refused to explain.

Let's hope the replacement is fit for purpose.
