## 1 Introduction

**MUSCAT QUALITY SERVICES** is leading Omani company specialized in providing product certification services which is authorized by Directorate General of Standardization and Metrology (DGSM). DGSM gives the responsibility to issue the Certificate of Conformity for several products, and based on the procedures and requirements of the Food Safety & Quality Center, a Certificate of Conformity for **Food Products** is required to clear the product from the borders/ ports.

## 2 Scope of the Scheme, including the Type of Products covered and Type of Product Certification Scheme

This document describes a system for the Evaluation and Certification of **Food Products**.

This Scheme is operated under the ownership of **Muscat Quality Services Conformity Certification** and is bound to be followed by **MUSCAT QUALITY SERVICES** and its Client. ## 4 Terms and Definitions

**For the purposes of this document, the definition is as below for better understanding:**

1. **Client** – Organization or Person responsible to a Certification Body for ensuring that Certification Requirements, including Product Requirements, are fulfilled.
2. **Consultancy** – participation in the designing, manufacturing, installing, maintaining, or distributing of a Certified Product or a Product to be Certified, or the designing, implementing, operating, or maintaining of a Certified process or a process to be Certified, or the designing, implementing, providing, or maintaining of a Certified Service or a Service to be Certified.
3. **Evaluation** – combination of the Selection and Determination functions of Conformity Assessment Activities.
4. **Product** – result of a Process.
5. **Process** – set of Interrelated or Interacting Activities which transforms inputs into outputs.
6. **Service** – result of at least one activity necessarily performed at the interface between the Supplier and the Customer, which is generally intangible.
7. **Procedure** – specified way to carry out an activity or a process.
8. **Certification Requirement** – specified requirement, including Product requirements, that is fulfilled by the Client as a condition of establishing or maintaining Certification.
9. **Product Requirement** – requirement that relates directly to a Product, specified in standards or in other Normative Documents identified by the Certification Scheme.
10. **Certification Scheme** – Certification system related to specified Products, to which the same specified requirements, specific rules and Procedures apply.
11. **Scope of Certification** – identification of the Product(s), process(es) or service(s) for which the Certification is granted, the applicable Certification Scheme, and the Standard(s) and other Normative Document(s), including their date of publication, to which it is judged that the Product(s), Process(es) or Service(s) comply.
12. **Scheme Owner** – Person or Organization responsible for developing and maintaining a specific Certification Scheme.
13. **Certification Body** – third-party Conformity Assessment Body operating Certification Schemes.
14. **Surveillance** – systematic iteration of conformity assessment activities as a basis for maintaining the validity of the statement of conformity.
15. **Testing** – determination of one or more characteristics of an object of conformity assessment according to the procedure.
16. **Inspection** – examination of an object of conformity assessment and determination of its conformity with detailed requirements or, on the basis of professional judgement, with general requirements.
17. **Identification Test** – A simple check or measurement used to confirm that the current production batch matches the certified reference sample.
18. **Review** – consideration of the suitability, adequacy and effectiveness of selection and

determination activities, and the results of these activities, with regard to fulfilment of specified requirements by an object of conformity assessment.

19. **Decision** – conclusion, based on the results of review that fulfilment of specified requirements has or has not been demonstrated.
20. **Attestation** – issue of a statement (Certificate) based on a decision that fulfilment of specified requirements has been demonstrated.
21. **Suspension** – temporary restriction of the Certificate of conformity by the body that issued the statement, for all or part of the specified scope of attestation.
22. **Withdrawal** – cancellation/revocation of the Certificate of conformity by the body that issued the statement.
23. **Conformity** – fulfilment of a requirement.
24. **Non-conformity** – non-fulfilment of a requirement.
25. **Impartiality** – presence of objectivity.
26. **Appeal** – request by the person or organization that provides, or that is, the object of conformity assessment to a conformity assessment body or an accreditation body for reconsideration by that body of a decision it has made relating to that object.
27. **Complaint**– expression of dissatisfaction, other than appeal, by any person or organization to a conformity assessment body or an accreditation body, relating to the activities of that body, where a response is expected.
28. **Corrective Action** – action to eliminate the cause of a nonconformity and to prevent recurrence.

## 6 Duties and Responsibilities

## 8 Certification Scheme

The Certification Scheme is designed based on Type 1a as per the ISO/IEC 17067. The Scheme covers: -

**a. Submit the application,**

The Client shall submit the application as per the DGSM requirement Ref: MQS -AFF Ver:00

**b. Review**

Examine the conformity requirements obtained during the determination stage, to determine whether the product is in conformity or not.

**c. Decision on Certification**

Granting, Maintaining, Extending, Reducing, Suspending, Withdrawing Certification.

**d. Attestation, Licensing**

- Issuing a Certificate of Conformity or other statement of Conformity (attestation).
- Granting the right to use Certificates or other statements of Conformity.

## 9 Sequence of Certification Cycle

The followings are the sequence of Certification Cycle, which are followed on a day-to-day basis: the client submits all the required files such as the test report, labeling and the manufacturer's certificate of composition through either the email or the **MUSCAT QUALITY SERVICES** software.

The Product Certification Assessor/Certification Manager checks all the documents to ensure that the tests are complying with the regulation requirements to issue the Certificate of Conformity.

### 11.0.5 Attestation

Following the decision to grant Certification, **MUSCAT QUALITY SERVICES** issues a statement of Conformity.

Under this Scheme, the statement of Conformity is in the form of a Certificate.

In addition, the Certified Client may place the Scheme's Certification Mark on the Product subject to a Licensing Agreement being entered into with **MUSCAT QUALITY SERVICES**.

### 11.1 Contents of Certificate of Conformity

The following information's are provided in the Certificate of Conformity as a minimum;

- Certificate Number
- Name and address of **MUSCAT QUALITY SERVICES**
- Name and Address of Client (certificate holder)
- Statement of Conformity, including:
  - Name and Unique Designation (Trade Mark) of Product
  - Production Sites and Country of origin
  - Applicable Standard(s) and other Normative Document(s) (including test report number)
- If applicable, reference to the Accreditation or Recognition Status of **MUSCAT QUALITY SERVICES** (Means status of ISO/IEC 17065 Accreditation)
- Date of Issue of Certificate
- Date of Expiry of Certificate
- Legally binding Signature(s) of Person(s) authorized to sign on behalf of **MUSCAT QUALITY SERVICES**.

## 11.2 Licensing Use of Certificates and Marks of Conformity

### 11.2.1 General

The use of the Certificate and Mark of Conformity is controlled through Certificate of Conformity issued by **MUSCAT QUALITY SERVICES** to each Organization which uses them on, or in conjunction with, Certified Products.

The Organization holding the Certificate of Conformity (referred to in this clause as the Licensee) may be different from the Client to which the Certificate was issued. Circumstances under which a different Organization might be involved include the following:

- the Client sub-contracts the manufacture of the Product, including the placing of the mark on the Product, to another Organization (the Manufacturer would need to be a Licensee)
- a Customer of the Client applies its own label, including the mark, to the Product under an agreement with the Client (the customer would need to be a Licensee)
- other cases.

In all cases, the Client ensures that **MUSCAT QUALITY SERVICES** has access to the Licensee's premises for Evaluation as agreed.

### 11.2.2 Mark of Conformity

Not currently applicable for FSQC.

## 11.3 Suspending or withdrawing a Certificate of Conformity

### 11.3.1 Suspension

The applicability of the Certificate of Conformity to a specific Product may be suspended for a limited period, for example in the following cases:

- if it shows that the Corrective Action taken on the non-conformity issued is not effective or satisfactorily discharged.
- if a case of improper use of the Certificate (e.g., misleading publications or advertisement) is not solved by suitable retractions and appropriate Corrective Actions by the Client.
- if there has been any other contravention of the Product Certification Scheme or the Procedures of **MUSCAT QUALITY SERVICES**.

The Client is prohibited from identifying as certified any product that has been manufactured or placed on the market under a suspension of the certificate of conformity as applicable to that product.

A certificate of conformity may also be suspended after mutual agreement between **MUSCAT QUALITY SERVICES** and the Client for a limited period of non-production or for other reasons.

An official suspension of a certificate of conformity is confirmed by **MUSCAT QUALITY SERVICES** in a registered letter to the Client (or by equivalent means).

The Client may give notice of appeal Ref: MQS-CAP, and **MUSCAT QUALITY SERVICES** when considering the appeal may or may not (depending on the nature of the case) decide to proceed with its decision to suspend the certificate of conformity.

**MUSCAT QUALITY SERVICES** indicates under which conditions the suspension would be removed, such as for example corrective action taken in accordance with Misuse of the Certificate of Conformity.

This document is exclusive property of the Muscat Quality Services SPC. Any partial or total reproduction of any kind is forbidden without prior approval of Management.

At the end of the suspension period, **MUSCAT QUALITY SERVICES** investigates whether the indicated conditions for re-instituting the certificate of conformity have been fulfilled.

On fulfilment of these conditions, the suspension is removed by notifying the Client.

### 11.3.2 Withdrawal

Apart from the Suspension of the Certificate of Conformity is withdrawn in the following cases:

- a. if the Client fails to comply with the due settlement of Financial Obligations.
- b. if there is any other contravention of the Certification Agreement.
- c. if inadequate measures are taken by the Client in the case of Suspension.

In the above cases, **MUSCAT QUALITY SERVICES** has the right to withdraw the Certificate of Conformity by informing the Client in writing concerning the specification of a time limit.

The Client may give notice of appeal Ref: MQS-CAP, and **MUSCAT QUALITY SERVICES** when considering the appeal may or may not (depending on the nature of the case) decide to proceed with its decision to withdraw the certificate of conformity.

Prior to withdrawal of a certificate of conformity, **MUSCAT QUALITY SERVICES** decides upon the consequences in relation to products covered by the certificate, whether a clearance of the stock of certified products is permissible within a short period of time. **MUSCAT QUALITY SERVICES** decides if other actions are required, including informing the clients.

Furthermore, the Certificate of Conformity may be withdrawn in the following cases:

- If the Client does not wish to maintain the Certificate of Conformity.
- If the Standard or Rules are changed and the Client either will not or cannot ensure Conformity with the New Requirements.
- If the Product is no longer made or the Certificate of Conformity goes out of business.
- On the grounds of other provisions specified in the certification Agreement.

### 11.4 Misuse of the Certificate of Conformity

**MUSCAT QUALITY SERVICES** takes action when unauthorized, incorrect, or misleading use of the certificates is found.

Incorrect references to the certification scheme or misleading use of certificates found in advertisements, catalogues, etc., are dealt with by suitable actions, which could include legal or corrective action or publication of the transgression.

## 12 Publicity by Client

The Client has the right to publish the fact that:

- a. an identified Product has been Certified
- b. the Client has been authorized to use a valid Certificate of Conformity

This document is exclusive property of the Muscat Quality Services SPC. Any partial or total reproduction of any kind is forbidden without prior approval of Management.

In every case, the Client takes sufficient care of its publications and advertising so that no confusion arises between Certified and Non-Certified Products.

The Client does not specify any function or make any claim or the like in user information that could lead purchasers to believe that performance of the Product or its use is covered by the Certification when in fact it is not.

In this example the Scheme requires **MUSCAT QUALITY SERVICES** to approve instruction books, manuals and other user information accompanying the Product.

## 13 Changes affecting Certification

### 13.1 Changes to Product Requirements

When a standard or another Normative Document that is part of the Certification Requirements is changed, there are a number of factors that have to be considered when fixing up the date on which the New Product Requirements of the changed document will come into force (effective date reflecting the transition period).

The effective date of obsolescence of a Standard or other Normative Document is communicated by **MUSCAT QUALITY SERVICES** to all applicable Clients to allow them adequate time to take appropriate action.

In those cases when the Standard development Organization responsible for the Standard or other Normative Document defines the transition period until which the superseded document is valid, this date defines the obsolescence of the superseded document unless otherwise stated by law or by the Scheme.

Further factors that are considered when choosing the effective date include, but are not necessarily restricted to, the following:

- a. Compliance with Regulations or Contractual Obligations
- b. The urgency of complying with revised Health, Safety, or Environmental Requirements
- c. The length of time and financial costs for retooling and manufacturing a Product complying with the revised requirements
- d. The extent of stock on hand and whether it can be reworked to meet the revised requirements
- e. Avoidance of unintentional commercial advantage given to a particular manufacture or design
- f. Operational constraints of **MUSCAT QUALITY SERVICES**.

### 13.2 Changes to Scheme Requirements

**MUSCAT QUALITY SERVICES** advises their clients if necessary, of changes in the Scheme requirements, such as:

- a. Test and examination Procedures where these are not contained in the standards or other Normative documents that specify the Product Requirements.
- b. Conditions for licensing of the certification mark
- c. Qualification criteria and Procedures for Conformity Assessment bodies participating in the Scheme.

### 13.3 Changes by Client

The Client informs **MUSCAT QUALITY SERVICES** about any intended modification to the Product, which may

affect the Conformity of the Product. **MUSCAT QUALITY SERVICES** determines whether the announced changes require another Initial Testing and Assessment or other further investigations. In such cases, the Client is not permitted to release Products under the Certificate resulting from such changes until **MUSCAT QUALITY SERVICES** has notified the Client accordingly.

A client wishing to extend the scope of certification to additional types or models of products, to the same specified requirements as the products for which a certification is already granted, applies to **MUSCAT QUALITY SERVICES** using an application form. In such cases, **MUSCAT QUALITY SERVICES** may decide to require or select test samples of the additional types of products to determine that they comply with the specified requirements. If the tests are successful, the scope of certification is extended.
