The Certification Program was designed and implemented based on internationally recognized manuals and guidelines, including:

The program was developed with a total workload of 200 hours, combining theoretical instruction with fieldwork in different communities across the territory.

Evaluation results demonstrated a strong level of achievement, with participants reaching an average score of 94% across all modules.
