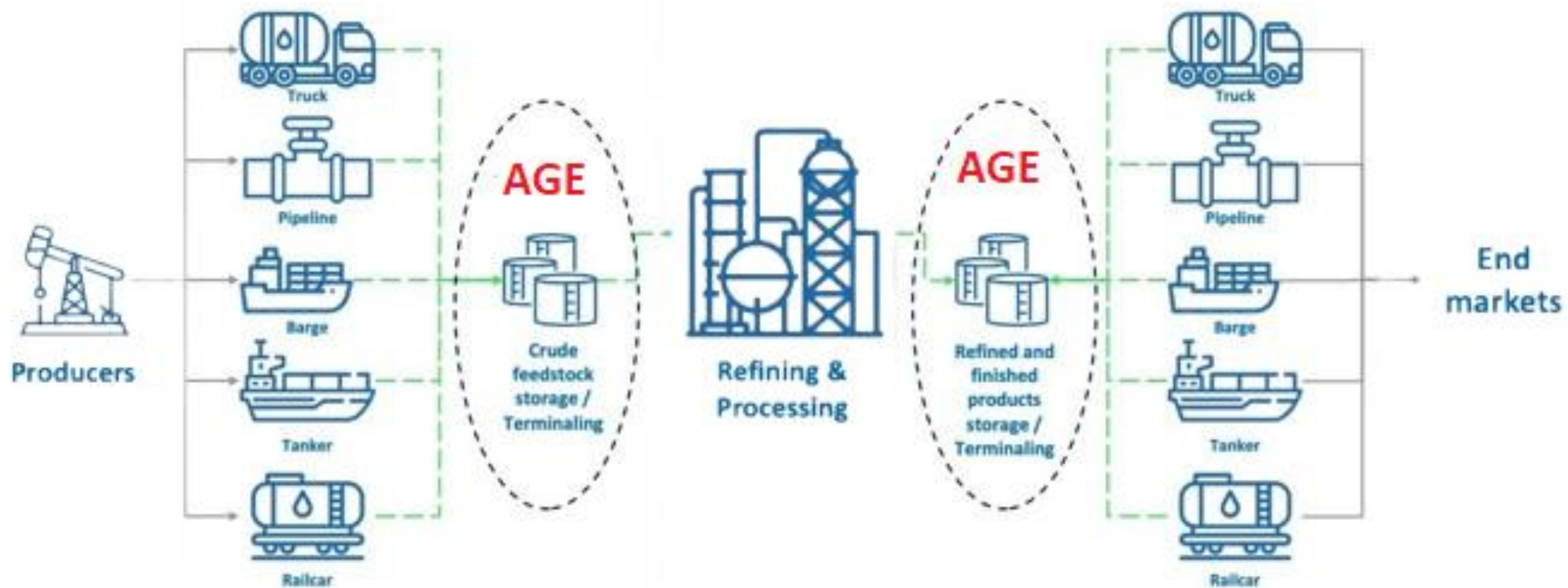

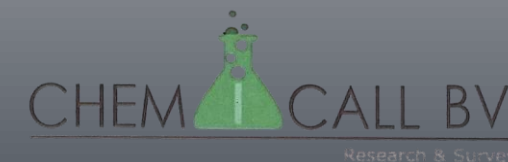

Hello Thierry Catherine,

We would like to inform you that the equipment has already been shipped directly from our vendor, who is located in UK.

The receiver is pre-configured and ready to start working immediately when connected, that is if your network supports automatic IP address assignment (DHCP). Connect it directly to your router via an Ethernet cable, to the VHF antenna and to the power supply. If there is no DHCP active, please check the setup guide in order to set up the unit using hotspot mode.

Sometimes, the first boot may last 15 minutes should there be any update available.

In order for the unit to be discovered on your local network, you may use a third party application such as Advanced IP scanner (<https://www.advanced-ip-scanner.com>)

Midgard Oil Trading FZC is to be identified as station **ID 6822**.

The receiver makes use of the following ports:

- 12142 - This is the destination port for your unit.
- 443 TCP - This is the most fundamental requirement - it is used to connect to the VPN and the web terminal, and many web endpoints using TLS (<https://>.)
- 123 UDP - For NTP time synchronization.
- 53 UDP - For DNS name resolution.

Each of these should work with outward only (and inward once outward connection is established) firewall settings.

Additionally, you should whitelist the following IP / domains for the relevant ports above:

- 5.9.207.224
- *.marinetraffic.com
- *.balena-cloud.com
- *.newrelic.com

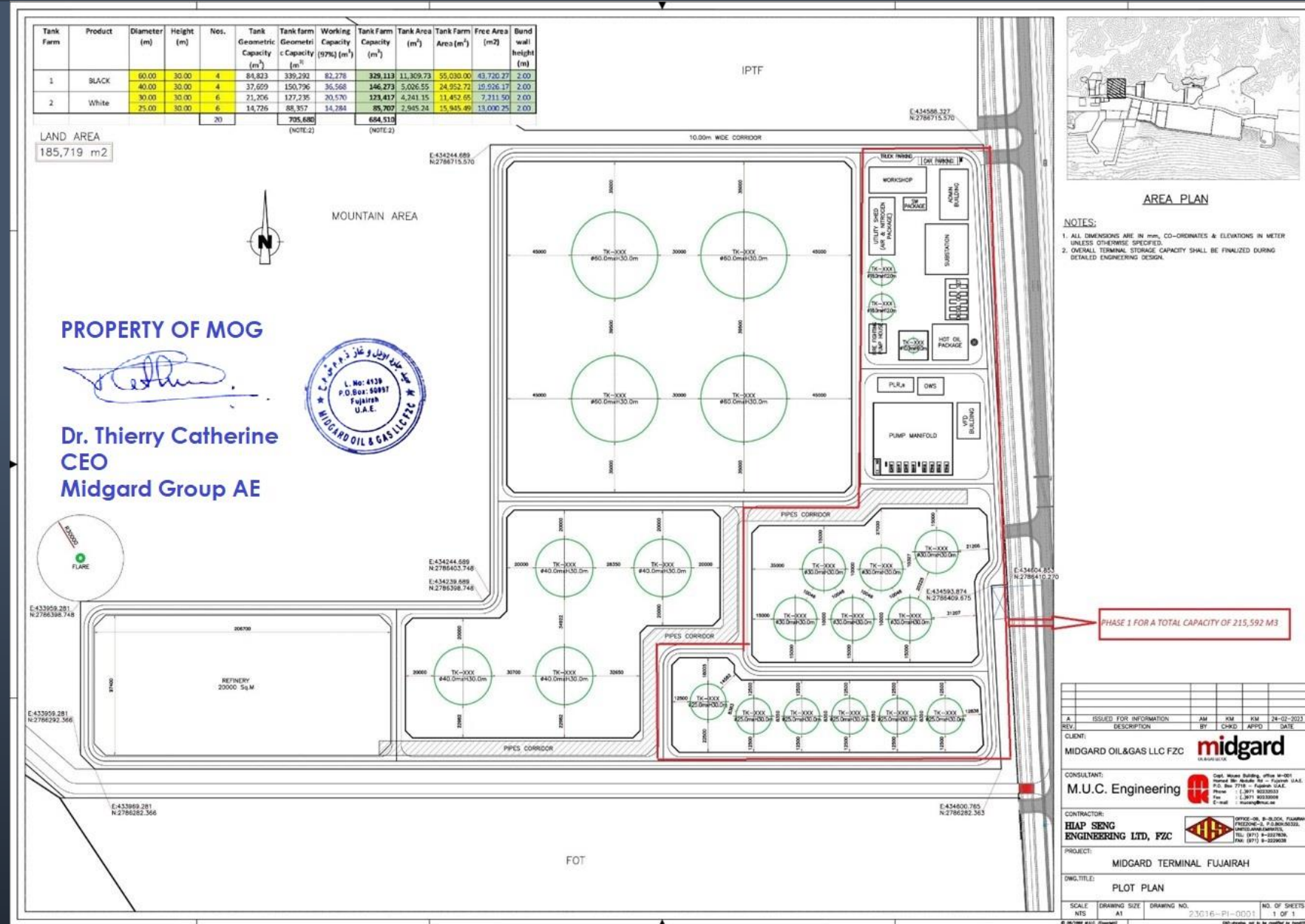
