There was a request to the Board of Directors to find a service that would automate dues payments for homeowners. We have selected a vendor and are completing the HOA receiver sign up. As soon as that is complete, we will provide homeowners information so that they can sign up for this service.

HOA Insurance Update: There are 3 outstanding Requests for Proposal. All are for 'walls out' insurance, which should provide some financial relief. Multiple brokers have told us that we will remain in the expensive, secondary market until we are a minimum of 2 years past our last insurance claim (end of September 2022). We are still looking for a premium which will allow us to reduce our monthly cost.
