HOA Insurance Update: One broker anticipates having a proposal for us in the next 10-14 days. This is for 'walls out' insurance, which should provide some financial relief. We are required to carry 3 distinct types of coverage – property, general liability and director/officer liability. We are still looking for a premium which will allow us to reduce our monthly cost. As soon as we have a proposal we will communicate with homeowners as we will all need to review our H06 coverage to align with new coverage.

Maintenance issues: We keep some fascia, siding and shingles in our shed. There have been 3 recent requests that we can take care of from this stock with the help of our new handyman. Please let a board member know if you have a need.

Accounts Receivable: Board members discussed the need to have a consistent policy/procedure if a homeowner falls into a 90-day delinquency. No one is currently in this category.
