Treasurers Report for Merimbula Basketball Association Annual General Meeting - 25th August 2025

Dear members,

I am happy to report that the organisation remains in a sound financial position for the financial year ending 30 June 2025. The Detailed Profit & Loss report and Balance Sheet have been provided and will be reported to the Department of Fair Trading upon completion of the AGM.

Notable income for the year include Domestic Competition fees of \$51,119.11 and Signage Sponsorship of \$7,925.00. Notable expenses for the year include referee payments of \$14,097.50, Representative Referee travel allowances of \$12,550.00 and the purchase of merchandise of \$15,962.79.

The club currently holds \$50,000 in term deposit earning high interest. These funds are available for potential future projects.

Merimbula Basketball Association (MBA) and Bega Valley Shire Council (BVSC) have come to an agreement to share the costs associated with the maintenance of our retractable basketball hoops. In April of 2025, BVSC made a contribution of \$11,446.00. This was to reimburse MBA for out of pocket expenses incurred as a result of a mechanical failure, resulting in the requirement of upgraded hardware. BVSC have agreed to contribute 50% towards the costs of ongoing quarterly maintenance inspections and repairs.

Netball & MBA agreed to use club grants 10k to contribute to new club development.

Our canteen continues to be a stable source of income. With sales totalling \$19,905.84 and expenses of \$10,300.51, it has produced a respectable profit of \$9,605.33.

We have received grants and sponsorships, which have assisted with our increased spending for the year. We have received generous donations from ClubGrants, Bendigo Bank and numerous local businesses which assist in providing a valuable service to our community.

We anticipate similar financial projections for the 2026 financial year.

Challenges have no doubt continued for MBA, however with good people taking action where needed we have seen little impact on our competitions. The next big – however extremely exciting challenge – will be working with Bega Valley Shire Council, the Labor Government and other facility stakeholders on the much needed clubhouse upgrade. It will take time, but we now know it is a live project gaining momentum, with design work progressing and construction funding committed.

Again, the continued success of the MBA comes thanks to the many volunteers who give up their time to make basketball happen in Merimbula. Special thanks go to:

- The executive committee Mandi Grenenger, Grahame Ford, Esther Furniss and Jess Porter. MBA's engine room working countless unseen hours to keep MBA thriving.
- The referee group as I said in last year's report, refereeing is perhaps the most challenging role in basketball. Know that without you, our competitions and representative program would not be the success that they are.
- The coordinator group again an enormous effort behind the scenes and on match days to ensure each competition is set up properly, runs smoothly and is as even as possible. Included in this group are our canteen and merchandise teams who play a vital role in maintaining MBA's financial viability.
- Our sponsors through domestic competitions jerseys, the new rep sponsorship format, signage, discounted goods and services or in-kind donations, your contribution to the financial position helps the MBA flourish and continue to provide basketball opportunities in our region.
- The development and representative subcommittee for many hours of continued investment in developing all on-court aspects of the MBA.
