Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to Derby Hockey Club via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);

 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;

- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";
- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Derby Hockey Club and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Derby Hockey Club is the "data controller". This means that Derby Hockey Club determines the purposes for which, and the manner in which, your Data is processed.

Data collected

How we collect Data

- 6. We collect Data in the following ways:

Data that is given to us by you

- 7. Derby Hockey Club will collect your Data in a number of ways, for example:

Your rights
