

# Statutes

## § 1 of the Association name

The association's name is: ZWAP Cycling Club

## § 2 Purpose

Association has to purpose to:

ZWAP Cycling Club will promote cycling as an activity for people with Parkinson's , help create awareness of and raise charitable funds for the Parkinson's cause.

The purpose shall be achieved through the following activities:

- Organize bike rides/races that create attention and a basis for sponsorships
- Organize cycling training on Zwift or similar other digital platforms
- Facilitate information about digitally supported cycling as an exercise activity for people with Parkinson's
- Arrange a scheme for the collection of charitable funds in connection with the above

## § 3 Organizational form

Association is one standalone legal person with members, and is freehold. That it is self-ownership means that no one, neither members nor others, has a claim to the association's assets or assets, or is responsible for debts or other obligations.

## § 4 Members

Membership in the association is open to all persons connected to or interested in the Parkinson's case

## § 5 Rights and duties attached to the membership

Everyone members has straight to to participate on annual meeting, has voting rights and is selectable to position of trust in Association. Members who owe dues for more than one year do not have the right to vote or other rights, and the board can strike them as members of the association.

The members duties to relationship themselves to decision as is understood of annual meeting.

## § 6 Annual meeting

the annual meeting, as is held each year, is of the association highest authority. The annual meeting is approved with the number of voting members present, and all members have one vote. The chairman is elected by the annual meeting. The annual meeting can be held on an appropriate digital platform.

With less other is specific, shall a decision, for to be valid, be hit with general plural of the votes cast. Ties are decided by drawing lots.

The annual meeting is summoned of the board with smallest one monthly notice, direct to the members or by announcement on an appropriate digital platform. Proposals to be considered at the annual meeting must be sent to the board no later than two weeks before the annual meeting. A complete agenda must be available to members no later than one week before the annual meeting. The annual meeting can not treat suggestion as not is listed on the case list, with less 3/4 of the attended requires it.

## **§ 7 of the annual meeting tasks**

The annual meeting shall

- treat annual report
- treat accounting
- treat received suggestion
- fix quota
- adopt budget
- select
  - chairman of the board
  - board members
  - eventual deputies

## **§ 8 Extraordinary annual meetings**

Extraordinary annual meetings becomes held when the board decides the, or smallest 1/3 of the members requires it. Summons happens on same manner as for ordinary annual meetings, with smallest 14 of the day notice. Extraordinary annual meeting can just treat and toe decision in the the cases as is announced in the notice. Extraordinary annual meetings shall in principle not be able to elect board members, unless it is to replace individual members who have resigned for natural reasons or voluntarily, and the replacement member is then elected until the next annual meeting.

## **§ 9 The board**

The association has a board of 3 to 5 members and is elected by the annual meeting. Preferably all, but at least 50% of the board members must be people with Parkinson's disease . A maximum of 50% of the current board can be replaced each year.

The board is highest authority between the annual meetings. The board must hold a meeting when the chairman or a majority of the board members so request.

The board shall

- implement annual meeting regulations
- appoint eventual committees, selection or persons as shall do special tasks, and prepare instructions for these
- manage and lead necessary control with of the association economy in according to to applicable instructions and provisions
- represent Association outwardly

The board can grasp decision when a plural of of the board members is to present. Resolution understood with plural of the votes cast. The chairman has a double vote in the event of a tie.

## **§ 10 Signature right**

The chairman and one board member jointly own signature right.

## **§ 11 Amendment of articles of association**

Changes of these the statutes can just is done on ordinary or extraordinary annual meeting after to have been on the agenda, and a 2/3 majority of the votes cast is required.

## **§ 12 Resolution**

Resolution of Association can just is processed on annual meeting, and requires 2/3 plural.

The association's fortune shall after resolution and debt settlement accrue the purpose Association worker to promote, in that the net assets are given to a non-profit organization that the annual meeting decides.
