#### **PREAMBLE**

We, the members of AMINA USMAN GLOBAL FOUNDATION a not for-profit and non-political organisation do firmly and solemnly resolve to provide for ourselves a constitution and to be governed by the provisions therein contained.

#### **ARTICLE 1: NAME**

The name of the Association is AMINA USMAN GLOBAL FOUNDATION

#### **ARTICLE 2: ADDRESS**

#### **ARTICLE 3: AIMS AND OBJECTIVES**

SN	THE AIMS AND OBJECTIVES OF THE ASSOCIATION ARE:

#### **ARTICLE 4: TRUSTEES**

- A. The Trustees of AMINA USMAN GLOBAL FOUNDATION for the purpose of the Companies and Allied Matters Act CAP C20 LFN 2004, shall be elected at a General Meeting charged with responsibility of selecting the Trustees with 2/3 majority votes of members present.
- B. Such Trustees (Hereinafter referred to as, "The Trustees") shall not be less than 2 and more than 15 in number.
- C. A Trustee may hold office for 5 years but shall cease to hold office if he:
  - 1. Resigns his office
  - 2. Ceases to be a member of the registered Trustees of the body.
  - 3. Becomes insane
  - 4. Is officially declared bankrupt
  - 5. Is convicted of a criminal offence involving dishonesty by a Court of competent jurisdiction
  - 6. Is recommended for removal from office by a board of Governors and Trustees majority vote of members present at any General Meeting of the body
  - 7. Ceases to reside in Nigeria
- D. Upon a vacancy occurring in the number of Trustees a General Meeting will be held to appoint another eligible member of the Association.
