2026 Utah State Umpire Association Compensation and Points of Contact Sheet

Utah State Umpire Association Compensation – 2026 SPRING LEAGUES

- **Per umpire**, 60-, 70-, **80-, 90-** foot bases, \$60 for 1 hour 45-minute time limit, + \$5 for each extra inning if the game is tied and time has run out and play is continued.
- **One umpire, 80- and 90-foot bases**, \$90 for 1 hour 45-minute time limit, + \$5 for each extra inning if the game is tied and time has run out and play is continued.
- **Arbiter Pay Schedule**, \$5 per game scheduled.

Note: If you operate a tournament there is a different standard, this is for LEAGUE PLAY only.

Utah State Umpire Association Compensation – 2026 FALL LEAGUES

- **Per umpire**, 60-, 70-, **80-, 90-** foot bases, **\$65** for 1 hour 45-minute time limit, + \$5 for each extra inning if the game is tied and time has run out and play is continued.
- **One umpire, 80- and 90-foot bases**, **\$100** for 1 hour 45-minute time limit, + \$5 for each extra inning if the game is tied and time has run out and play is continued.
- **Arbiter Pay Schedule**, \$5 per game scheduled.

Note: If you operate a tournament there is a different standard, this is for LEAGUE PLAY only.

Rain outs/Cancellations:

If a game is rained out or cancelled and the Utah State Umpire Association arbiter is not notified by the league, the umpire will receive pay for one game. If a game is rained out or cancelled due to bad weather or any other condition outside the league's control prior to the umpire taking the field, it is recommended the league pay the umpire \$20 compensation for time and travel. If any game has started and is called due to rain or unsafe playing conditions, the league will be responsible for paying the umpire/s for that game. I.E., 1) If game one of a double header is started and rained out or cancelled, each umpire will receive the pay for one game and will not receive pay for game two. 2) If game one of a double header is completed and game two is started and then called due to rain or other conditions, each umpire will receive the pay for game one and game two. Any games started and called due to rain or unsafe playing conditions, then rescheduled, regardless of the remaining time or innings to be played, the umpire/s will receive a full game compensation for the rescheduled game.

Contact Procedures:

Any issues with **scheduling** should be addressed to the Arbiter. **All issues with umpires should be with your board member for your league, first. Any inappropriate behavior, foul or vulgar language, conduct unbecoming an umpire to the USUA standards should/must be reported! PLEASE!** If you do not report your



experience, we as the board will be unable to rectify the situation. We work for you and want you to have the best interaction possible with you, your players, coaches, and fans. We also encourage any positive feedback from your facilities. This lets us know the improvements we are instilling in the USUA umpires are working and we are providing the best possible on and off the field professionalism to your league. Again, if we don't know we cannot refine our directions. If your board member does not respond timely, please reach out to the President or Vice President. If the issue becomes immediate and you are not receiving the required attention, then reach out to the Arbiter and they will get ahold of the appropriate board member on your behalf.
