Drake Hill Homeowners Meeting Minutes January 10, 2024 6:00 p.m.

The new President, Bob Clements, opened the meeting by introducing the other Board members, Shelley Weselo (secretary) and Doug Britt (treasurer). Bob was elected to the Board by the Board in September upon notification that Carla Phillips was selling her house and moving out of the community.

Susan talked about the financials. We fell just a little short on the budget this past year. Our biggest expense was tree removal. Dues will not be increased for next year. We collected some late fees and money from the Clark lawsuit along with mailbox reimbursements from new homeowners. The homeowners present agreed to move \$10,000 into savings. This would give us almost a full year's budget of reserves in our savings account.

When closing on a house, a new mailbox is ordered for that address. 2458 Manita paid for a mailbox, but it was never replaced. They replaced it and then someone hit it. Susan will check into why a new one was not put up when they moved in.

Officer Cooper is having the city put a "curve ahead" sign up near his home on Trumpeter since they will not do a speed study for humps. Hopefully, this will help with the awareness of the curve so people are less likely to run into his property. The board has also agreed to make sure that area on Trumpeter/Manita is well salted before cold weather and storms occur.

Muskrats in the pond area – Bob bought a couple of traps and set them up, but then there was a freeze. Won't be able to catch them until Spring now.

Officer Cooper encouraged people to call the Mayor's Action Line for potholes. The phone number is 317-327-4622. He was recently successful in having the potholes at Ringed Neck and Trumpeter filled. Thank you!

Talked about the bridge and the electrical panel for the fountain in the pond. It also supplies the electrical for the corner light. Susan to contact the city to see if a solar light can be put in and maintained by the city. Susan also wants to have the electric bill put back in our HOA name instead of hers. It has been in her name for about ten years because at one point (during the embezzlement years) our bill was not being paid so she had to have it put in her company name.

There are several homes in the community that need to be power washed this Spring. It was suggested to use Wet and Forget as it works well and helps prevent regrowth. Bob had some suggestions of what not to do, such as not spraying water into the vents under the soffits. Also, if paint is spayed off, the wood will begin to rot. Bob has noticed a couple of houses that have rotting trim that needs to be repaired. For homes that do not comply and clean their houses, a letter will be sent. Also, a working yard lamp must be maintained in all front yards.

Open Discussion: Mowing of common areas. Grass is being blown back into homeowner's yards. Clippings on the pond too. Susan will have them do two full passes blowing it away from the ponds.

Walking trail. Supposed to start working on it this Spring. They have hired Susan to replant the grass on both sides of the trail. They are going to try to have the trail run in between the mounds as much as possible.

There was a conversation about how thieves have been going through mailboxes looking for checks. Sunningdale has had this problem as well. Please make sure you report all thefts or when you know your cars have been gone through. Please make sure you lock your cars to prevent theft.

The Board will contact Yvonne McCann to see if she is interested in restarting the website and keep docs on there as well as ACC forms. She did a great job of running this previously.

No soliciting allowed. Marion County has a No-Knock List. Must reregister every January. The no soliciting sign is missing off the 21st street entrance. Susan will make sure it is replaced.

Unused wetlands near pond on Manita/Ringed Neck. Homeowner (Arnold) at 2459 Ringed Neck drive would like to purchase it. Susan to look it up on an aerial map.

Susan stated paying HOA dues electronically is an option, but there is a fee of \$25. Please mail your checks or pay online through your bank account to avoid extra fees. The link for electronic payment is www.crestwoodmgmt.com.

There were no further questions and Bob closed the meeting.
