Role Executive Officer	<ul> <li>Safety Responsibilities</li> <li>The Executive Officer of Hawgood Haulage is ultimately accountable for the safe operation of the business. They are responsible for: <ul> <li>defining the Safety Management System (SMS) policies and objectives</li> <li>implementing the SMS and making sure it operates effectively</li> <li>communicating the importance of the SMS to the business</li> <li>providing the resources (personnel and funding) necessary to meet SMS requirements</li> <li>leading by example in promoting safe work practices</li> </ul> </li> </ul>
	<ul> <li>staying up to date with the safe conduct of transport activities</li> <li>monitoring safety performance in the business</li> <li>ensuring all employees have the ability to work safely and comply with business policies and procedures</li> <li>empowering employees to speak up about safety issues</li> <li>promoting health and wellbeing (e.g. mental health) for all involved in the transport activity</li> <li>fostering a positive safety culture within the business</li> <li>complying with Hawgood Haulage policies, procedures and training requirements.</li> </ul>

Safety The Safety Manager is responsible for:		
Manager	<ul> <li>complying with Hawgood Haulage safety policies, procedures and training requirements</li> </ul>	
	<ul> <li>the management and oversight of the SMS</li> </ul>	
	<ul> <li>reporting safety-related issues directly to the owner</li> </ul>	
	<ul> <li>ensuring risk management activities are carried out and regularly reviewed</li> </ul>	
	<ul> <li>reporting and collating all safety events, hazards and near misses</li> </ul>	
	<ul> <li>reviewing all reports of safety issues, hazards, risks and near misses, and conducting investigations (as required)</li> </ul>	
	<ul> <li>monitoring compliance with safety policies and procedures</li> </ul>	
	<ul> <li>openly communicating with employees, customers and contractors about safety practices and issues</li> </ul>	
	<ul> <li>leading by example in promoting safe work practices</li> </ul>	
	<ul> <li>promoting health and wellbeing (e.g. mental health) for all involved in the transport activity</li> </ul>

Managers	Managers are responsible for:	
	<ul> <li>complying with Hawgood Haulage safety policies, procedures and</li> </ul>	
	training requirements	
	<ul> <li>ensuring all employees work safely and comply with business policies and procedures</li> </ul>	
	<ul> <li>ensuring risk management activities are carried out and regularly reviewed</li> </ul>	
	<ul> <li>bringing accidents and serious incidents to the attention of the Safety Manager and providing resources and information for any subsequent investigation</li> </ul>	
	<ul> <li>reviewing investigation reports and other reports involving employees to ensure adequate corrective actions have been initiated to prevent recurrence</li> </ul>	
	<ul> <li>developing and administering reasonable safety goals and objectives</li> </ul>	
	<ul> <li>reviewing compliance with safety policies and procedures</li> </ul>	
	<ul> <li>communicating the following in a timely manner to all employees within their area of responsibility: outcomes of incidents and accidents, safety goals and objectives, departmental and organisational safety performance and noteworthy safety-related issues</li> </ul>	
	<ul> <li>promoting health and wellbeing of their employees</li> </ul>	
	<ul> <li>developing a high degree of safety awareness among employees— motivating employees to think, act and work safely.</li> </ul>

	<ul> <li>participating in safety and risk management activities</li> </ul>
