Hayes whispered, "This looks like a bear... or something bigger."



## CHAAAYEST


His reflection catches in the glass. Eyes — yellow. Teeth — sharp. He's changing.

# EPILOGUE — CASE FILE: THE HUNGRY PARTNER

Filed: August 3, 1976

Department: Richmond Police Department, Internal Affairs

Following the "RVA-01476" incident, all files related to Detective Warren Hayes and Officer Leon Price were sealed under federal review. The station itself was condemned after unexplained power failures and recurring reports of howls echoing from the basement.

Officer Lisa Grant transferred to another district two weeks later. She filed for leave and never returned.

Witnesses near Southside still report seeing two shadowed figures wandering the old precinct grounds on humid nights – one in uniform, the other crawling on all fours.
