

Madam/Sir,

In inviting a reference to the subject cited above, this is to inform you that the Constitution mandates nodal role for PRIs to undertake local area planning for Economic Development and Social Justice. For this purpose the People's Plan Campaign (PPC) is being rolled-out in the State from 2nd October 2025 to 31st January 2026.

1. The People's Plan Campaign (PPC) has been rolled out since 2018, and over the last seven years it has emerged as a significant platform for strengthening participatory planning at the grassroots level. The campaign has enabled Gram Panchayats to prepare comprehensive, convergent and inclusive Gram Panchayat Development Plans (GPDPs) with active involvement of the PRIs, community & line departments, thereby ensuring that local needs and priorities are duly reflected in the planning process.
2. Generally during People's Plan Campaign period two special Gram Sabhas are held. In the first Gram Sabha environment is created for preparation of Plan and the draft Plan process is initiated. During the second Gram Sabha, Development Plan (GPDP) of the GP is finalized. Since frontline

workers of the line department are the key stake holders, their participation in Gram Sabha and planning process is utmost importance to prepare evidence based comprehensive and inclusive GPDP. It is expected that line department officials will disseminate features of their schemes, resources; convergence mechanisms etc and finally facilitate the planning by incorporating activities of their departmental action plan into GPDP.

3. In view of that, it has been decided to conduct Peoples Plan Campaign in the entire State to prepare comprehensive Panchayat Development Plan (GPDP,BPDP,DPDP) for the year 2026-2027 taking into consideration the following matters.

- Formation of GPPFT (GP level Planning Facilitation Team) should be ensured involving GP Standing Committee Members, representatives / Frontline workers of various line departments, SHGs Federations and retired eminent persons, who can voluntarily devote their service for preparation of thematic GPDP.
- Convening Special Gram Sabha (2 nos) for initiating and approval of the GPDP.
- Convening Panchayat Samiti (2 nos) and Zilla Parishad meeting (2 nos) for initiating and approval of the BPDP and DPDP respectively.
- Organizing meetings of 'Bal Sabha' and 'Mahila Sabha' prior to Gram Sabha meetings to facilitate enumeration and articulation of needs of children and women.
- Organizing Gram Sabha meeting and Schedule / Calendar using Panchayat Nirnay Application.
- Invitation to the frontline workers of line departments and others to attend the special Gram Sabha and share the schemes currently available as well as eligibility of various schemes.
- Ensuring maximum attendance of the Gram Sabha members in the Gram Sabha meeting and provide equal opportunity to the members to place their demands.
- Panchayat Advancement Index (PAI), Information which will be used to assess the progress and identify the gaps to prepare plan and implement the same to saturate the requirements in a phased manner.

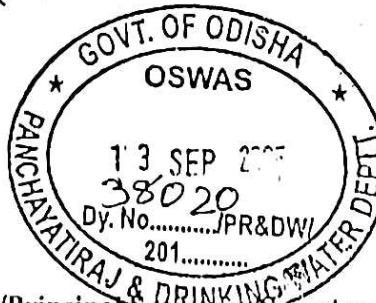



For smooth implementation, a training programme will be conducted on 20.09.2025 at 11:00 AM through MS Teams for all District Panchayat Officers (DPOs), District Project Managers (DPMs) and Programme Manager (IT). The meeting link will be shared separately.

You are, therefore, requested to take necessary steps for ensuring

conduct of Gram Sabha in all Gram Panchayats of your District on 2nd October, 2025 and upload the proceedings on SabhaSaar Portal. Compliance may be reported to this Department under intimation to MoPR.

Dear Madam/Sir,

As you are aware, Ministry of Panchayati Raj (MoPR) has taken an instrumental initiative in the field of Artificial Intelligence (AI) through the development of SabhaSaar - An AI Powered Tool for Automated Gram Sabha Minutes Documentation which was launched by the Hon'ble Minister of Panchayati Raj on 14th August, 2025 (accessible at <https://sabhasaar.panchayat.gov.in/>). This tool has been designed to automatically generate structured Minutes of Meeting (MoM) from video/audio recordings of Gram Sabha in a pre-defined format, in English as well as 12 official languages listed in the 8th Schedule of the Indian Constitution (Hindi, Marathi, Tamil, Telugu, Kannada, Malayalam, Gujarati, Bengali, Odia, Urdu, Punjabi & Sanskrit). More languages will be added to the list in due course. This initiative ensures zero manual documentation, reduction in time and workload, complete coverage of all discussed agendas, automated archival of records, and hence, overall strengthening of the rural governance system.

2. As decide, special Gram Sabhas were conducted on 15th August, 2025, wherein the proceedings were recorded and uploaded on the SabhaSaar portal for generating the Minutes of Meeting (MoM). As per information available, till 9th September, 2025, a total of 13,441 Gram Panchayats have participated and uploaded their videos/audios on the portal for the automated MoM generation. State-wise breakup is placed as Annexure-I.

3. It has now been decided that SabhaSaar may be adopted widely at all Panchayat levels for the Gram Sabha meeting to be conducted on 2nd October, 2025 on the occasion of Gandhi Jayanti. Accordingly, state-wise targets for conducting Special Gram Sabhas and uploading proceedings at the Gram Panchayat level on SabhaSaar portal have been placed as Annexure-II.

4. May I therefore request you to direct the concerned officials to ensure achievement of the target for your State for the Gram Sabha meeting to be conducted on 2nd October, 2025. 
