Madam/ Sir,

In enclosing herewith the communication received from Ministry of Panchayati Raj, Government of India vide their DO Letter dtd. 20.04.2026 on the subject cited above, I am directed to say that **24th April** is observed every year as *National Panchayati Raj Diwas (NPRD)* to commemorate the enactment of the 73rd Constitutional Amendment Act, which conferred constitutional status upon Panchayats and marked a defining milestone in decentralized governance in India.

The Ministry has requested all States/UTs to organize the celebration of NPRD, 2026 in a befitting manner and to ensure observance of the occasion at **District and Block levels**, with emphasis on participatory and citizen-centric initiatives.

In this connection, this Department has already issued instructions vide Letter No. **10748, dated 17.04.2026** regarding organization of **State, District and Block level celebrations**, wherein the **State Level function is scheduled to be held at Balangir district**.

It is further to inform that the **State Level Celebration will be held at 6:00 PM on 24.04.2026**, which will be **live telecast through electronic media platforms**. You are, therefore, requested to ensure that necessary arrangements are made at **District and Block levels** for facilitating **viewing of the live telecast** by PRI representatives, officials and general public, so as to enable maximum participation and outreach.

Further, **Gram Sabha meetings** shall be convened at Gram Panchayat level with adequate prior notice ensuring wide participation of citizens and functionaries of line Departments. The programmes may include **felicitation of well-performing Panchayats, awareness generation activities, community engagement initiatives**, and discussions on themes such as women-led development, Panchayat Advancement Index (PAI), Localisation of Sustainable Development Goals (LSDGs), and enhancement of Own Source Revenue (OSR).

The Gram Sabhas may also utilize *SabhaSaar* for preparation of structured Minutes of Meetings. Adequate arrangements may be made for ensuring maximum public participation (*Janbhagidari*) and dissemination of information on Panchayati Raj initiatives.

Expenditure towards organization of such activities may be met from available funds of PRIs, preferably from **Own Source Revenue (OSR)** or IEC component of RGSA and other Central/State sponsored schemes, as applicable.

Necessary arrangements may also be made for **wide publicity and outreach**, including appropriate use of electronic and social media platforms, to ensure effective dissemination at the grassroots level.

You are further requested to ensure that all necessary administrative and logistical arrangements are made well in advance for successful observance of NPRD, 2026.

The **action taken report** along with brief details of activities conducted may be furnished to this Department for onward transmission to office of Hon'ble Chief Minister and Government of India.

You are, therefore, requested to issue necessary instructions to PRIs/ Rural Local Bodies under your jurisdiction accordingly and ensure that the objectives of NPRD, 2026 are achieved in letter and spirit.

Gram Sabhas may utilize **SabhaSaar** to prepare structured Minutes of Meetings. NPRD-2026 may be celebrated with great fervour and maximum Janbhagidari (people's participation). Expenditure on related activities may be met from OSR or the IEC component of RGSA and other Central/State rural development scheme funds. In poll-bound States where the Model Code of Conduct (MCC) is in force, its provisions shall remain applicable.

5. All necessary administrative and logistical arrangements may kindly be made well in advance to ensure the successful and wholesome observance of NPRD on 24th April, 2026. The action plan for observance of NPRD-2026 and the actions taken in this regard may be shared with the Ministry at <behera.bk@nic.in> and <ak.tiwari12@nic.in>. States/UTs are also requested to follow and tag the official social media handles of the Ministry of Panchayati Raj in all NPRD-related posts and updates for wider visibility and coordinated national outreach.
