Sub: Operation of a Dedicated OSR Account in a Centralized /Nationalized Bank at the Gram Panchayat Level regarding.

Madam/Sir,

In inviting a reference to the subject cited above, I am to say that The Panchayati Raj & Drinking Water Department, in collaboration with NIC Odisha, is developing a new web-based Own Source Revenue (OSR) portal to strengthen revenue generation at the Gram Panchayat level. This portal is designed to streamline tax and non-tax revenue systems, enabling efficient and transparent management of GP finances. It will also facilitate seamless online transactions, allowing citizens to conveniently pay their dues. During the pilot implementation of the above portal, it was observed that accounts of the GPs maintained with Gramin Banks are not being validated on the portal. It was also noticed that multiple OSR bank accounts are being operated by certain Gram Panchayats, which may lead to operational difficulties and reconciliation issues.

In view of the above, and for ensuring smooth and effective state-wide rollout of the OSR portal, it is hereby advised that each Gram Panchayat shall operate one dedicated OSR bank account only in a Centralised/Nationalised Bank, selected from the empanelled list of banks notified by the Finance Department, Government of Odisha.

This may be ensured at the earliest for seamless integration with the OSR portal.

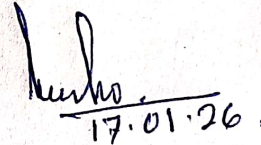

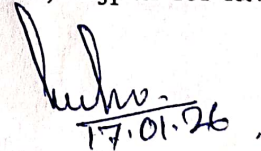
