Conditions for entering our vocal classes:

- Entry must include teacher's name, competitor's address, and competitor's date of birth, telephone number and email address.
- To ensure that a prize is available for every class, donations from competitors and their families are important. Your contribution, however small, will be most appreciated.
- Where there are fewer than three entrants in a class, the class may be cancelled for that particular year.
- 2nd prizes will be awarded only if there are 4 or more entrants in the class and 3rd prizes will be awarded only if there are 6 or more entrants in the class.
- Please contact the convener if you would like the names of available accompanists
- If this competition has to be cancelled due to any unforeseen circumstances, any entry fees paid will be returned minus the administration fee (\$30) which will be kept to cover costs incurred for the event.

Time limit:

Class 136 Oratorio and Class 138 Aria (8 minutes). The Adjudicator has the option of ringing the bell to stop the Performance when the time limit has been reached.

Music:

Copies for the Adjudicator must be handed in 10 minutes before class commences and each piece for individual classes must be separated and labeled with the competitor's name, number and Class No. clearly printed on the front. Please ensure that Adjudicator copies are unmarked and without loose pages.

No CD backing tracks are allowed at the Senior Christchurch Vocal Competitions.

A number of accompanying pianists are available in Christchurch and we can pass on their contact details if you require a pianist.

Eligibility of entrants:

(Note this replaces Clause 1 (c) of the Christchurch Competitions Society General Conditions and applies to the Vocal Section only). Any entrant who, with the exclusion of Seminars, Summer Schools and Masterclasses, has been taught by the Adjudicator at any time during the two year period immediately prior to the Competitions shall NOT be eligible to compete.

The Executive shall decide the eligibility of any entry and may decline to accept it. The receiving of any entry in good faith at the Society's Office does not imply acceptance. Compliance with the conditions relative to any entry is the responsibility of the entrant. Enquiries regarding eligibility should be addressed to the Convenors.

Class order:

The order of classes in this Syllabus may not be the order in the final programme. That will be determined by the number of entries in each class and the times available.

Christchurch Aria:

Upon entering the Christchurch Aria Class 138 we require on separate cover the title of each Opera and a short synopsis, these can be emailed directly to Otautahi.vocal.comps@gmail.com

Only arias nominated on the entry form are to be performed. No changes are permitted, unless under Extenuating circumstances and approved by the Adjudicator. Competitors in the Aria class must also enter and compete in class 125, 131 and in at least one other class.

Participants in Class 138, are NOT to enter with the same aria from previous years. Participants who disregard this entry condition may risk being withdrawn from the competition or disqualified.

Accommodation:

Entrants from outside of Christchurch requiring accommodation are invited to contact the Ōtautahi Vocal Convener.

Prize monies:

Prize monies awarded are subject to suitable donations being received. The Society reserves the right to alter or amend any prize monies awarded in any class.

Item changes:

Changes can be made but once the Programme has been printed then the option to change is not permitted, unless approved by the Conveners and the Adjudicator.

- 1. Competitors shall be 15 and under 21 years of age as at 1st October 2025.
- 2. Each competitor performs from memory, a programme of 2 stand alone/independent contrasting pieces maximum of <u>7 minutes</u>, each from fully staged Musicals and **NOT** from TV adaptations. The two pieces must **NOT** be from the same Musical.
- 3. The programme MUST include at least one example of scene into song.
- 4. The spoken excerpt of the scene into song, can be taken either from the original published musical theatre work OR devised by the competitor and should develop both the character and the story.
- 5. The programme should feature the integration of acting, singing and movement/dance and competitors must perform all three.
- 6. Props are permitted but they must be handheld and not require any assistance.
- 7. Competitors will be accompanied [No Backing tracks]
- 8. Every other year Class 137 will be OPEN.

Class 138 Conditions

- 1. Open to any person 18 years and over as at 1 June 2025.
- 2. Entry fee \$70.00.
- 3. Competitors may provide their own accompanist. However, the society has accompanists available, if required, at the competitor's own expense. If you intend to use one of these the societies Accompanists, please contact the convener for their details and make contact with them prior to the closing date to advise them what you will sing and arrange rehearsal times if required. It is the singer's responsibility to arrange these rehearsals.
- 4. At the time of registration entrants must nominate two Operatic Aria, one to be sung in the preliminary round and a second contrasting Operatic Aria to be sung should they be selected for the Aria Final. Changes can be made but once the Programme has been printed then the option to change is not permitted, unless approved by the Convener and the Adjudicator.
- 5. A brief description of the characters, opera synopsis and the aria's context MUST accompany the entry. Applicants, please write this as an introduction to be read out by the Master of Ceremonies before you sing with a maximum of <u>200</u> words. Failure to do so will result in NO introduction for the competitor. Please note that competition converors will not chase competitors for this information.
- 6. Participants in Class 138, are **NOT** to enter with the same aria from previous years. <u>Participants who disregard this</u> entry condition may risk being withdrawn from the competition or disqualified.
- 7. The Preliminary Round will be held at The Piano, 156 Armagh St, Christchurch, 7.30 pm on Friday 20th June 2025. A maximum of six competitors will be recalled for the Final to be held at The Piano, 7.30 pm on Saturday 21st June 2024.
- 8. Aria Finalists will repeat their chosen Aria from the Preliminary Round and their second Aria as nominated during the registration process. Any Aria chosen for this class cannot be used in any other class during this festival
- 9. Arias must be sung in the original key and language.
- 10. Competitors in the Aria class must also enter and compete in class 125, 131 classes and in at least one other class. The committee reserves the right to withold any prize money should any Competitions fail to adhere to this rule
- 11. A biography about each competitior (<u>max. 100 words</u>) must be included with the entry form during registration or the entry will not be accepted.



NATIONAL YOUNG PERFORMER AWARDS 2025 CRITERIA FOR MUSICAL THEATRE

- A. Competitors shall be 15 and under 25 years of age as at 1st October 2025
- B. Each competitor shall perform in three classes during the preliminary round:
 - 1. Piece 1: Stand alone, independent piece from a fully staged musical and NOT from a TV adaption. Maximum of seven minutes in duration
 - 2. Piece 2: Stand alone, independent piece from a fully staged musical and NOT from a TV adaption. Maximum of seven minutes in duration
 - 3. Master Class run by the Adjudicators. No audience observation.
- C. The two Pieces in B1 and B2 must NOT be from the same Musical and MUST show breadth of repertoire with Piece 2 showing a clear contrast to Piece 1.
- D. Both Piece 1 AND Piece 2 MUST each include at least one example of scene into song.
- E. The spoken excerpt of the scene into song, can be taken either from the original published musical theatre work OR devised by the competitor and should develop character and story.
- F. Both Piece 1 and Piece 2 MUST feature the integration of acting, singing and dance and competitors must perform all three.
- G. Props are permitted but they must be handheld and not require any assistance.
- H. A backing track MUST be provided and will include music and silence as required for the full performance. There will be <u>NO</u> cueing from the Stage Manager. The track will be cued at the start of each Piece and will not be touched again.
- I. A penalty of 5 marks will be imposed if the time limit is exceeded by 30 seconds or more.
- J. There will be a semi-final at which competitors will repeat either B1 or B2 at the discretion of the adjudicator. Competitors will be chosen based on their marks in the three Preliminary round(s).
 - The number of semi-finalists will be decided in accordance with the NYPA rules.
- K. For the Final Award Concert, three competitors will be recalled and shall repeat the item not performed at the semi-final.
- L. Costumes, choreography & music should be appropriate to the age of the competitors and suitable for a family audience this will be at the Adjudicators' discretion.
- M. This competition is for amateur performers only and is not open to professionals*.

NB: Males can sing female roles and vice-versa. No distinction between genders.

Nomination of competitors by Societies should be based on classes B1-B2 i.e. with or without the Master Class

SOCIETY NOMINATION

Each Society, which is a financial member of PACANZ, may nominate up to two competitors, who shall be selected by the adjudicator, based on a performance as outlined in A-D (above). The adjudicator will determine that a competitor has displayed a sufficient standard of performance to competently represent that society at the National Young Performer Awards. The standard required will be at the absolute discretion of the adjudicator but will include;

- A demonstration of adequate preparation and an authority of performance
- A performance with a level of maturity commensurate with a national final competition of this age group.

If the adjudicator considers that sufficient standard has NOT been reached by any competitor, then NO nomination will be made.

The Nominating Society is responsible for paying part of the entry fee to the National Young Performer Awards, which is \$75.00 incl gst.

The Nominee is responsible for paying their portion of the entry fee to the National Young Performer Awards, which is \$230.00 incl gst.

DIRECT NOMINATION:

Via a Competition Society Member

If the adjudicator considers that more than two competitors have reached a sufficient standard, the adjudicator may report to the committee that those competitors should be given the option of a DIRECT NOMINATION.

Via a Tertiary Institution Member

Nominations may also be put forward if Musical Theatre students have reached a sufficient standard and can meet the Criteria listed above.

The DIRECT NOMINATION competitor will be responsible for paying the full entry fee, which is \$305.00 incl gst

* A professional is someone whose primary employment is being paid to perform or work in the performing arts. For the present purposes, being a student constitutes "primary employment" and therefore is not seen as a Professional. For the Student who receives payment for participation, either teaching or performing, this should not impose professional status on a person if it is by way only of an occasional bonus or benefit rather than their <u>principal</u> means of earning a livelihood.
