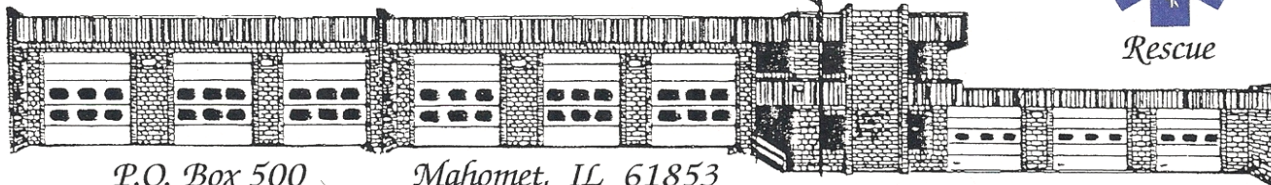

Please read verbatim:

A. I move to go into closed session 5ILCS 120 / 2 (c) (1) To discuss the appointment, employment compensation, discipline performance or dismissal of specific employees;

B. I move to go into closed session 5ILCS 120/2(c)(11) to Discuss litigation, when an action against, affecting or on Behalf of the particular public body has been filed and is Pending before a court or administrative tribunal, or when the Public body finds that an action is probable or imminent, in which case the basis for the finding shall be recorded and entered into the minutes of the closed meeting.

C. I move to go into closed session 5ILCS 120/2 (c)(5) to discuss the purchase or lease of real property for the use of the public body, including meetings held for the purpose of discussing whether a particular parcel should be acquired.

D. I move to go into closed session 5ILCS 120/2 (c) (6) to discuss the setting of a price for sale or lease of property owned by the public body.

E. I move to go into closed session 5ILCS 120/2 (c) (21) for the Discussion of minutes of meetings lawfully closed under this Act, Whether for purposes of approval by the body of the minutes or Semi-annual review of the minutes as mandated by Section 2.06.

F. I move to go into closed session 5ILCS 120/2 (c) (21) for the Discussion of Collective negotiating matters between the public body and its employees or their representatives, or deliberations concerning salary schedules for one or more classes of employees.
